The Board of Advisors will help guide the Alliance as it tracks implementation and progress against its aggressive goals, which include inspecting 100 percent of Alliance garment factories by July 2014, implementing a comprehensive worker training program and helpline, and providing remedial support for factories to address safety issues.

To-date, the Alliance is making good progress towards these goals. More than 40% of factory inspections have been completed, training programs are underway, the worker helpline will roll out to 50 factories this month, and the foundation has been built to provide important technical support and oversight of the remediation process so that factories can be upgraded and improved.

"We recognize the significance of Bangladesh's garment industry to the country's economic growth, and the jobs it provides its people," said advisory board member Dan Glickman of the Bipartisan Policy Center. "While the challenges in Bangladesh are many, the Alliance is making significant progress towards strengthening the working conditions in the ready-made garment industry and the well-being of its workers."

The Alliance for Bangladesh Worker Safety was founded by a group of North American apparel companies, retailers and brands who joined together to develop and launch the Bangladesh Worker Safety Initiative, a binding, five-year undertaking that will be transparent, results-oriented, measurable and verifiable with the intent of improving safety in Bangladeshi ready-made garment (RMG) factories.

The Alliance provides global apparel companies and retailers the unprecedented opportunity to come together and put forward concrete solutions to issues that impact apparel and retail industries worldwide.
